## Doctrinal Statement

**We believe** that the Scriptures of the Old and New Testaments are the infallible Word of God, a divine revelation, the original manuscript of which was verbally inspired by the Holy Spirit, and that they are the supreme and final authority of faith and conduct. Matt. 5:18; John 5:39-47; II Timothy 3:16-17; II Peter 1:21

**We believe** in one God, eternally existing in three persons; Father, Son and Holy Spirit. Each of the three persons is worthy of equal honor, obedience, and worship. Matt. 28:19; John 5:23; II Cor. 13:14

**We believe** that God the Father is in a special sense the Father of the Lord Jesus Christ, His only begotten Son, and that He is the Father of only those who accept the Lord Jesus Christ as their personal Savior. Psalm 2:7; John 1:12-13; John 8:19; Gal. 3:26

**We believe** that Jesus Christ was begotten by the Holy Spirit, was born of the virgin Mary, and is truly God and truly man. We believe that He was crucified for our sins and that in that same body in which He had lived and died He arose from the dead. In that body glorified He ascended into heaven. He as our high priest is now at the right hand of God interceding for us. We believe in that "blessed hope", the personal and imminent return of our Lord Jesus Christ, which will precede the age of universal peace and righteousness foretold in the Scriptures. **We believe** that man was created in the image of God, and is not in any sense the product of animal ancestry or the development of brute humanity; but that the whole human race fell into the sin of the first Adam and apart from Christ is spiritually dead and lost, and no one can of himself gain recovery or be restored into the family of God. **We believe** that Jesus Christ died a substitutionary death upon the cross, by grace providing salvation for all who believe on Him, justifying them alone on the ground of His shed blood. John 3:16; II Cor. 5:21; Ephesians 2:8; Hebrews 9:22

**We believe** that all who by faith receive the Lord Jesus Christ are born of the Spirit of God and so become children of God, that eternal life is a present possession, that at death their spirits depart to be with Christ in conscious blessedness, and that at Christ's second coming their bodies will be raised and together with the living believers, transformed into the likeness of the body of His glory. John 1:12-13; Philippians 1:21-23; I Thess. 4:13-18; I John 3:1-3; I John 5:12

**We believe** that all those who persistently reject Jesus Christ in the present life shall be raised from the dead, not to be annihilated nor ultimately to be restored, but throughout eternity exist in a state of conscious torment. John 3:36; II Thess. 1:9; Rev. 20:10

**We believe** that Satan is a person, the enemy of God and His people, that in his warfare he appears as "an angel of light" and that, as a usurper, he now rules as the "god of this world." We believe that he was judged at the cross and, therefore, ultimately he shall be cast into the "lake of fire." Mark 1:12-13; II Cor. 11:13-15; II Cor. 4:3-4; Rev. 20:1-3

**We believe** that the church consists of all those who, in this dispensation, truly believe on the Lord Jesus Christ, and that it is the body and bride of Christ. The mission of the church in this age is to witness for Christ among all nations. Therefore, she must be careful to strengthen herself by preaching and teaching the Word of God "for the edifying of the body of Christ." Matt. 28:19; Acts 1:8; Acts 2:41&47; I Cor. 12:13; Ephesians 4:12

**We believe** that baptism should be administered only on confession of faith in the Lord Jesus Christ as personal Savior from sin. We believe in the present ministry of the Holy Spirit by whose indwelling the Christian is enabled to live a Godly, separated life; exalt the Lord Jesus Christ as Savior and Lord; and witness to His saving power in our various contacts with the world. Matt. 5:13-14 & 44; Matt. 28:19; Mark 16:16; Acts 2:38; Romans 12:18; II Cor. 6:14; James 5:12

**We believe** the New Testament use of "tongues" was an Apostolic sign gift to proclaim the mighty works of God to every nation under heaven in their own language. (Joel 2:26-32; Acts 2:5-21; I Cor. 14:20-22) The Holy Spirit's purpose in causing tongues was to authenticate those specially appointed representatives of Christ, that is, the Apostles. Tongue speaking was a sign of His presence and ministry for the purpose of validating the Apostolic message before it was inscripturated. The purpose of Biblical Tongues limits them to the apostolic age. In light of historical and grammatical interpretation of Scripture, we believe the gift of tongues is not a valid gift for today and therefore we will not allow its practice or propagation at Berean Academy. I Cor. 13:8-10; Eph. 2:19-20

## Statement on marriage, gender and sexuality

Regarding marriage, gender and sexuality, Berean Academy believes the following:

1. We believe that God wonderfully and immutably creates each person as male or female. These two distinct, complementary genders together reflect the image and nature of God (Gen. 1:26-27). Rejection of one's biological sex is a rejection of the image of God within that person.
2. We believe that the term "marriage" has only one meaning: the uniting of one man and one woman for life in a single, biblical, covenant union as delineated in Scripture (Gen. 2:18-25).
3. We believe that God intends sexual intimacy to occur only between a man and woman who are married to one another. (I Cor. 6:18; 7:2-5; Heb. 13:4)
4. We believe that God has commanded that no intimate sexual activity be engaged in outside of a traditional marriage (one man and one woman).
5. We believe that any form of sexual immorality (including adultery, fornication, homosexual behavior, bisexual conduct, bestiality, incest and use of pornography) is sinful and offensive to God (Matt. 15:18-20; I Cor. 6:9-10).
6. We believe that to preserve the function and integrity of Berean Academy and to provide a biblical role model to the community, it is imperative that all persons employed by Berean Academy in any capacity, or who serve as volunteers, agree to abide by this Statement on Marriage, Gender and Sexuality (Matt. 5:16; Phil. 2:14-16; I Thess. 5:22).
7. We believe that God offers redemption and restoration to all who confess and forsake their sin, seeking His mercy and forgiveness through Jesus Christ (Acts 3:19-21); Rom. 10:9-10; I Cor. 6:9-11).
8. We believe that every person must be afforded compassion, love, kindness, respect and dignity. (Mark 12:28-31; Luke 6:31) Hateful and harassing behaviors or attitudes directed toward any individual are to be repudiated and are not in accord with Scripture of the goals of Berean Academy.

Berean Academy is a ministry of Christian education, which serves as an extension of the Christian home. As such, the leadership of the ministry has a significant responsibility to ensure that the policies and practices of the school reflect what the Bible teaches in the area of harmony and unity in the lives of the Berean family and how harmony and true Christ-like love can be restored when conflict arises.

Conflict is part of the human experience and Christians and Christian ministries are not immune to its perils. One of Satan's most effective tactics is to push conflict to the next levels of resentment and bitterness in order to undermine the effectiveness of the ministry.

God's word is clear that Christians can and should resolve these conflicts in Christian love and mercy and not allow discord and strife to take root. Hebrews 12:14-15 states, "Make every effort to live in peace with all men and to be holy ... See to it that no one misses the grace of God and that no root of bitterness grows up to cause trouble and defile many." I Peter 3:8-9 admonishes believers to "live in harmony with one another, be sympathetic, love as brothers, be compassionate and humble." Ephesians 4:32 clearly directs us to "be kind, tenderhearted, and forgive one another as God forgave us." These are more than platitudes- they are the foundation for resolving conflicts that arise within the Berean family.

1. It is the policy of Berean Academy that any member of the Berean family that has an issue, concern or feels that they or their child have been treated wrongly in any way, should go to the person, (in this context a teacher, administrator, staff member, board member or parent) and seek to resolve the conflict. This expectation is the first step in the Berean Reconciliation Policy and is based on guidance from Matthew 18:15-17.
2. If the issue is not resolved, the next step in the process is to use the chain of command and bring the issue to the next level of authority. Hebrews 13:17 speaks about submission to those God has put in authority and Berean has an established order of responsibility and accountability with the principals, superintendent, and a school board. For example, if a person has met with a teacher and wants to go to the next step, he or she would go to the administration to seek resolution.
3. The next step in the Policy is to bring the issue to the Berean Board Reconciliation Committee. The Board Reconciliation Committee is comprised of at least three members from the Board, staff, or constituency, with consideration for avoiding any potential conflict of interest, who would oversee the process outlined by the Policy. This committee would serve for the duration of the issue at hand and guide the process of reconciliation. Written requests for this step of the process should be made to the Board President.
4. If people feel strongly that they cannot go to the affected party or administration in person, then they may request a member or members of the Berean Reconciliation Committee go with them to meet and seek resolution. Additionally, if it becomes known to the Berean leadership that a party has a concern that needs

to be resolved and has not utilized the Reconciliation Policy process, the Reconciliation Committee will take steps to engage the issue proactively to foster the needed resolution. This would involve trying to bring the affected people together voluntarily in a context of Christian love and guidance and follow through till the issue is resolved. While the board encourages following the process in order, it is the goal of Berean leadership to achieve reconciliation through all avenues.

It should be everyone's hope and prayer that these efforts will serve to maintain harmony in the Berean family and to prevent small issues or misunderstandings from becoming major matters of contention. There will be no coercion of individuals to comply with this policy, as the intent is to achieve reconciliation from willing hearts. However, we urge all members of the Berean family to prayerfully consider this Biblical process of reconciliation.

# Student Conduct Statement

*A commitment to Jesus Christ, to an evangelical fundamental church, and to Christian education is essential for each family at Berean. Please read and discuss this with your student(s), then sign and return.*

Students are expected to abide by these standards throughout their enrollment, whether at home, school, or elsewhere.

1. Students are to regularly attend an evangelical church.
2. Students are to work to their academic potential.
3. Students are to show respect and obedience to authority.
4. Students are to practice courteousness. They are not to handle other people's property unless they have the owner's permission.
5. Students are asked to help maintain a clean, neat campus. We anticipate no vandalism. Accidental property damage should be reported.
6. Couples shall not isolate themselves from others. Their conduct shall be in good taste, as becoming Christian young people.
7. Students shall practice discretion and restraint in the choice of television programs and other public programs, music, movies, theater, printed matter, and organizations with which one associates.
8. Students are not to associate with practices known to be morally wrong by Biblical standards, such as stealing, slandering, profane or vulgar language, all forms of dishonesty, occult practices, and sexual sins.
9. TOTAL ABSTINENCE is the standard for gambling, all forms of tobacco, the possession or use of alcoholic beverages, non-medical narcotics and all other drugs.
10. Students are to dress modestly and appropriately for each occasion. Today's fashion trends vary in appropriateness for wear at Berean. Recognizing that this is subject to interpretation, the administration will make the final decision in matters of judgment. Students are expected to respond with cooperation to these decisions.
