Employees will manifest by precept and example the highest Christian virtue and personal decorum both in and out of school to pupils, and as an example to parents and fellow staff members in judgment, dignity, respect, and Christian living. This includes, but is not limited to, refraining from such activities as the use of alcohol, tobacco, illicit drugs, and the use of vulgar and profane language (Colossians 3:17; Titus 2:7-8; I Thessalonians 2:10, 5:18, 22-23; and James 3:17-18). Any promiscuity, homosexuality, or other deviant sexual behavior is forbidden, and as such violates the bona fide occupational requirement of being a Christian role model. The unique role of male and female are clearly defined in Scripture. Romans 1:24-32 states that God recognizes homosexuals and other deviates as perverted. Deviation from Scriptural standards is grounds for termination (Romans 12:1-2; 1 Corinthians 6:9-20; Ephesians 4:1-11, 5:3-5; I Thessalonians 4:3-8; I Timothy 4:12; II Timothy 2:19-22; I Peter 1:15-16, 2:15-17; and I John 3:1-3).

I. DOCTRINAL STATEMENT

I. We believe that the Scriptures of the Old and New Testaments are the infallible Word of God, a divine revelation, the original manuscript of which was verbally inspired by the Holy Spirit, and that they are the supreme and final authority of faith and conduct. (Matt. 5:18; John 5:39, 46-47; II Timothy 3:16-17; II Peter 1:21)

II. We believe in one God, eternally existing in three persons; Father, Son and Holy Spirit. Each of the three persons is worthy of equal honor, obedience, and worship. (Matt. 28:19; John 5:23; Acts 5:3-4; II Cor. 13:14)

III. We believe that God the Father is in a special sense the Father of the Lord Jesus Christ, His only begotten Son, and that He is the Father of only those who accept the Lord Jesus Christ as their personal Savior. (Psalm 2:7; John 1:12-13; John 8:19; Gal. 3:26)

IV. We believe that Jesus Christ was begotten by the Holy Spirit, was born of the virgin Mary, and is truly God and truly man. We believe that He was crucified for our sins and that in that same body in which He had lived and died He arose from the dead. In that body glorified He ascended into heaven. He, as our high priest, is now at the right hand of God interceding for us. We believe in that "blessed hope", the personal and imminent return of our Lord Jesus Christ, which will precede the age of universal peace and righteousness foretold in the Scriptures. (Isaiah 53:5-6; Matt. 1:18, 23; Matt. 24:29-30, 42; Luke 1:35; John 20:25-28; Acts 1:11; Romans 1:3-4; Hebrews 7:25-27; Rev. 20:1-6)

V. We believe that the Holy Spirit is a person, possessing all the distinctively divine attributes, and is sent by the Lord Jesus Christ to convict of sin, to indwell, to guide, and to teach the believer and empower him to live in victory over sin. (John 16:7-15; I Cor. 2:10; Gal. 5:16, 22-23)

VI. We believe that man was created in the image of God, and is not in any sense the product of animal ancestry or the development of brute humanity; but that the whole human race fell into the sin of the first Adam and apart from Christ is spiritually dead and lost, and no one can of himself gain recovery or be restored into the family of God. (Genesis 1:26-27; John 15:5; Romans 3:20; 5:12)

VII. We believe that Jesus Christ died a substitutionary death upon the cross, by grace providing salvation for all who believe on Him, justifying them alone on the ground of His shed blood. (John 3:16; II Cor. 5:21; Ephesians 2:8; Hebrews 9:22)

VIII. We believe that all who by faith receive the Lord Jesus Christ are born of the Spirit of God and so become children of God, that eternal life is a present possession, that at death their spirits depart to be with Christ in conscious blessedness, and that at Christ's second coming their bodies will be raised and together with the living believers, transformed into the likeness of the body of His glory. (John 1:12-13; Philippians 1:21-23; I Thess. 4:13-18; I John 3:1-3; 5:12)

IX. We believe that all those who persistently reject Jesus Christ in the present life shall be raised from the dead, not to be annihilated nor ultimately to be restored, but throughout eternity exist in a state of conscious torment. (John 3:36; II Thess. 1:9; Rev. 20:10)

X. We believe that Satan is a person, the enemy of God and His people, that in his warfare he appears as "an angel of light" and that, as a usurper, he now rules as the "god of this world." We believe that he was judged at the cross and, therefore, ultimately he shall be cast into the "lake of fire." (Mark 1:12-13; II Cor. 4:3-4; II Cor. 11:13-15; Rev. 20:1-3)

XI. We believe that the church consists of all those who, in this dispensation, truly believe on the Lord Jesus Christ, and that it is the body and bride of Christ. The mission of the church in this age is to witness for Christ among all nations. Therefore, she must be careful to strengthen herself by preaching and teaching the Word of God “for the edifying of the body of Christ.” (Matt. 28:19; Acts 1:8; 2:41, 47; I Cor. 12:13; Ephesians 4:12)

XII. We believe that baptism should be administered only on confession of faith in the Lord Jesus Christ as personal Savior from sin. We believe in the present ministry of the Holy Spirit by whose indwelling the Christian is enabled to live a Godly, separated life; exalt the Lord Jesus Christ as Savior and Lord; and witness to His saving power in our various contacts with the world. (Matt. 5:13-14, 44; 28:19; Acts 2:38; Romans 12:18; II Cor. 6:14; James 5:12)

XIII. We believe the New Testament use of “tongues” was an Apostolic sign gift to proclaim the mighty works of God to every nation under heaven in their own language. (Joel 2:26-32; Acts 2:5-21; I Cor. 14:20-22) The Holy Spirit’s purpose in causing tongues was to authenticate those specially appointed representatives of Christ, that is, the Apostles. Tongues speaking was a sign of His presence and ministry for the purpose of validating the Apostolic message before it was inscripturated. The purpose of Biblical Tongues limits them to the Apostolic age. In light of historical and grammatical interpretation of Scripture, we believe the gift of tongues is not a valid gift for today and therefore we will not allow its practice or propagation at Berean Academy. (I Cor. 13:8-10; Eph. 2:19-20)

XIV. We believe that the term marriage has only one meaning: the uniting of one man and one woman in a single, exclusive union, as delineated in Scripture (Genesis 2:18–25). We believe that God intends sexual intimacy to occur only between a man and a woman who are married to each other (1 Corinthians 6:18, 7:2–5; Hebrews 13:4). We believe that God’s command is that there be no sexual intimacy outside of or apart from marriage between a man and a woman.

XV. We believe that God wonderfully foreordained and immutably created each person as either male or female in conformity with their biological sex. These two distinct yet complementary genders together reflect the image and nature of God. (Genesis 1:26–27).

J. STATEMENT ON MARRIAGE, GENDER, AND SEXUALITY

Regarding marriage, gender and sexuality, Berean Academy believes the following:

- We believe that God wonderfully and immutably creates each person as male or female. These two distinct, complementary genders together reflect the image and nature of God (Gen. 1:26-27). Rejection of one's biological sex is a rejection of the image of God within that person.
- We believe that the term "marriage" has only one meaning: the uniting of one man and one woman for life in a single, biblical, covenant union as delineated in Scripture (Gen. 2:18-25).
- We believe that God intends sexual intimacy to occur only between a man and woman who are married to one another. (I Cor. 6:18; 7:2-5; Heb. 13:4)
- We believe that God has commanded that no intimate sexual activity be engaged in outside of a traditional marriage (one man and one woman).
- We believe that any form of sexual immorality (including adultery, fornication, homosexual behavior, bisexual conduct, bestiality, incest and use of pornography) is sinful and offensive to God (Matt. 15:18-20; I Cor. 6:9-10).
- We believe that in order to preserve the function and integrity of Berean Academy as a Christian ministry and to provide a biblical role model to the community, it is imperative that all persons associated with the school as students, parents, employees, volunteers or members of the Laymen's Association agree with and commit to abide by this Statement on Marriage, Gender, and Sexuality (Matt. 5:16; Phil. 2:14-16; I Thess. 5:22).
- We believe that God offers redemption and restoration to all who confess and forsake their sin, seeking His mercy and forgiveness through Jesus Christ (Acts 3:19-21); Rom. 10:9-10; I Cor. 6:9-11).
- We believe that every person must be afforded compassion, love, kindness, respect and dignity. (Mark 12:28-31; Luke 6:31) Hateful and harassing behaviors or attitudes directed toward any individual are to be repudiated and are not in accord with Scripture of the goals of Berean Academy.
