Other Ways to Give

IRA Qualified Charitable Distributions

- If you have an Individual Retirement Account (IRA), and are 70 ½ or older, you can make a Qualified Charitable Distribution (QCD), by donating some or all of your IRA to Berean Academy. A QCD to Berean is not taxed, nor is it included in your taxable income. The distribution check must be made payable from your IRA custodian directly to Berean Academy.

IRA Required Minimum Distributions

- For those who are at least 73 years old, a Required Minimum Distribution (RMD) is mandated by the IRS annually on all tax-deferred retirement accounts. Berean Academy can serve as the recipient for your yearly RMD. A benefit of giving a QCD gift is that it counts toward the RMD each year. Any distributions must be paid directly to Berean from your IRA custodian.

Donor Advised Funds

- With a Donor Advised Fund (DAF), you can designate gifts of any amount to be given to Berean Academy. This will allow you to take advantage of all the tax benefits that accompany a DAF while benefiting our school.

Stocks or Commodities Sales

- Gifting cash may not be the most cost-effective way for you to give. You can increase your potential impact, while experiencing significant tax savings, by giving non-cash assets. You can gift appreciated stock or marketable securities proceeds, farm commodities sales, or life insurance benefits.





Scholarship Granting Organization

- Berean has a Scholarship Granting Organization (SGO) partner, RenewaNation, that provides scholarships to families that meet the requirements. Funds must be raised through Berean's donor base, but there are many benefits to this program including receiving a **75% state income tax credit**, plus other tax advantages.
